## V. Discussion of the Upcoming City Election

Randy Howard handed out the Shopper with two pages of information concerning the upcoming election. The Times Recorder newspaper will also have the same information later this week. And both will soon have copies of sample ballots printed there as well.

We have completed the Logic and Accuracy of the equipment. We will begin setting up for Early Voting this week. Early Voting will be at the Country Club during October 12 to 29, including the two Saturdays, from 8 am to 5 pm. Voting on Election Day, November 2, will be at the three precincts in Americus – GSW Conference Center, Recreation Department, and Reese Park.

We are keeping Americus up to date as to what is happening. Various local clubs have requested email and phone numbers to give to the public. There are candidate presentations

and forums scheduled at places like the Chamber of Commerce and Kiwanis Club. Everything is going well so far.

Some discussion followed regarding the number of machines at each precinct, and the community reach of newspapers.

## **VI. Discussion of Future Election of Commissioner for District 3**

Mr. Howard stated that it is because of unfortunate circumstances that we have to prepare for a special election. Mr. William Reid was a fine fellow, and he was well thought of in the community.

Attorney Kim Reid has been researching the law pertaining to having a special election.

Kim Reid gave a thorough overview of the laws and statutes pertaining to a special election. These laws outline the requirements and time frames that are needed before an election can be held. Taking this into account, and also in discussion with the Secretary of State's Office, this special election will not be able to be held at the same time as the upcoming election on November 2<sup>nd</sup>. Therefore, in order to satisfy the requirements and time frames of the laws and statutes, the earliest date available to hold this special election (to elect a District 3 Commissioner to fill the remainder of the unexpired term) would be Tues, March 15, 2022.

Discussion followed for clarification of the requirements and time frames in the laws.

## **VII. Budget Discussion**

Mr. Howard will meet with the new Finance Director to discuss the current budget. He will soon be able to view more details of each line item in the budget.

Carson Walker reported that a community member said that our new website exceeded his expectations, and he is very pleased with the information found there.
