# Sumter County Board of Elections and Voter Registration Regular Meeting January 3, 2023 at 4:30 pm

#### I. Call to Order

The meeting was called to order by Chairman Dr. Shirley Latimore at 4:30 pm.

#### II. Roll Call

**a) Board Members:** Chairman Dr. Shirley Latimore, Carson Walker, Rhonda Reddick, Dr. Valerie Roberts, and Dennis Taylor.

## III. Motion to Adopt the Agenda

Rhonda Reddick made a motion to adopt the agenda. Dennis Taylor seconded the motion.

Motion carried.

#### IV. Election of Officers for 2023

Dr. Shirley Latimore explained that at the beginning of every year, the Board's by-laws are followed to elect a chairman, a vice-chairman, and a secretary for the Board. She proceeded to conduct the election.

Dr. Latimore asked if all members were in favor of casting their votes by voice. All were in favor.

To serve as Chairman of the Board until the first meeting in 2024:

Dr. Latimore was nominated. The vote took place. All members were in favor. Therefore, Dr. Latimore will be the Chairman of the Board for the year of 2023.

To serve as Vice-Chairman of the Board until the first meeting in 2024:

Both Carson Walker and Rhonda Reddick were nominated. The vote took place. A majority voted for Rhonda Reddick. Therefore, Rhonda Reddick will be the Vice-Chairman of the Board for the year of 2023.

To serve as the Secretary of the Board until the first meeting in 2024:

Mr. Randy Howard was nominated. The vote took place. All members were in favor. Therefore, Mr. Howard will be the Secretary of the Board for the year of 2023.

Dr. Latimore stated that the election for officers for this year is now complete. All newly election officials will immediately take their positions.
